



## San Ramon FC 2017 Financial Aid Guidelines & Application

**\*CONFIDENTIAL\***

**Objective:** San Ramon Soccer Club, Inc., doing business as San Ramon FC (SRFC), provides interested and motivated youth the opportunity to play soccer at the level that fits their skill and ability. SRFC strives to keep soccer affordable, so all youth have an opportunity to participate. As such, the SRFC Financial Aid program is intended to provide opportunities for financially disadvantaged youth players to participate in SRFC programs.

**Privacy:** All Financial Aid applications and financial documentation information provided will be kept CONFIDENTIAL. For the privacy of our applicants, all documentation provided will be destroyed or returned (upon request) after the SRFC Financial Aid Committee approves or denies the request for financial aid.

### **Guidelines:**

- Financial need must be demonstrated for consideration. Economic hardship will be the only factor in awarding Financial Aid. No one will be disqualified from consideration because of sex, race, color, creed or religious beliefs.
- While we try to address as much of the need as possible, Financial Aid amounts will be based on the number of players demonstrating need, the extent of that need and the budget available for Financial Aid that year.
- Financial Aid awards will be reviewed on a yearly basis.

### **Criteria and Eligibility:**

To be considered you must:

1. Complete and submit an application for Financial Aid in its entirety.
2. Supply a copy of the first two pages of your 2015 and 2016 filed Federal Tax Returns. If you have not yet filed your 2016 return, supply a copy of your 2016 1099 or W2.
3. Supply a copy of the last three pay stubs for each working parent (or proof of EDD or Disability)...
4. Supply copies of your last 3 month's bank statements.
5. Supply copies evidencing sources of income, including child and spousal support.
6. Include any additional documentation demonstrating financial need.

Applications received after the published deadline or are not filled out completely (e.g., unanswered questions, missing supporting documentation, etc.) will not be considered. Applications must be filled out by the adult requesting Financial Aid and may not be filled out by coaches, team managers, children or friends. Any unpaid league fees from prior seasons will result in an applicant being ineligible for Financial Aid in the future.

### **Application of Financial Aid**

Financial Aid is applied only to Program Fees and Registration. Financial Aid does not cover any uniform costs, tournament fees, travel expenses (including, without limitation, transportation, lodging, and meals), or other expenses agreed upon or incurred by the team or by the individual player during the course of the program's season. Additionally, Financial Aid does not cover programs outside of the regular playing season such as camps, futsal, and skills academies (including juniors).

### **Volunteer Time:**

Financial Aid recipients can have their \$125 volunteer deposit waived, but recipients must perform **four (4)** hours of volunteer duties benefitting SRFC, which may include but are not limited to tournaments, tryouts, camps, or other club events. If the financial aid recipient fails to meet the volunteer obligation, then the volunteer deposit will be charged to your account.

### **Time Commitment and Participation:**

Financial Aid recipients must make reasonable efforts to attend all scheduled practices and games. Recipients must also actively participate in all team duties and activities.

### **Terms of the San Ramon FC Financial Aid Policy:**

After Financial Aid is awarded, the remaining balance of player registration and other applicable fees are to be paid in full according to the regular payment schedule. If an extended payment plan is approved, then all payments are due by August 1, 2017 for players born between 2010-2003 and December 1, 2017 for players born in 2002 or before. Failure to maintain financial good standing with SRFC will result in a player being ineligible to participate in the player's registered program.

The SRFC Financial Aid Committee meets as needed to process applications. SRFC reserves the right to discontinue Financial Aid at any time, if the information provided is inaccurate. **Note: Financial Aid is a partial award of SRFC fees; parents must continue to pay a portion of the fees based on the amount of financial aid awarded.**
